(c) Early start (footing/foundation)	\$100.00
(6) Manufacturing and Industrial Buildings or additions thereto	\$6 per 1,000 cubic feet or fraction thereof, up to 50,000 cubic feet, \$2.00 per 1,000 cubic feet over 50,000, \$25 minimum
(a) Plan Review (new or addition)	\$75.00
(b) Plan Review (alteration)	\$40.00
(7) Electrical (where building volume can be calculated):	\$1.15 per 1,000 cubic feet or fraction thereof, \$25 minimum
(a) Residential	\$2.00 per 1,000 cubic feet or fraction thereof, \$25 minimum

(8) Plumbing (where building volume can be calculated):	\$1.15 per 1,000 cubic feet or fraction thereof, \$25 minimum

(NOTE: permit is not required for roofing, siding and water heater replacement if you are replacing identical equipment)

(16) Occupancy (Note – fee to be paid with building permit)	
(a) Change of Occupancy (Non-residential)	\$30.00
(b) Residential (new)	\$20.00 + \$5.00 per unit
(c) Non-residential (New)	\$75.00
(17) Failure to obtain permits prior to commencement of work (may also be subject to other legal remedies)	DOUBLE FEES
(18) Proceeding with work without notification for required inspection (may also be subject to other legal remedies)	\$50.00

(a) Variance from State Code	\$75.00 (contact Wisconsin Department of Commerce, Safety and Buildings Division)
(20) Moving Permit	See Chapter 216 of this Code and Subsection E below.

(a) Principal building	\$20.00
(b) Accessory building	\$10.00
(22) Street opening	\$20.00
(23) Sign	\$10/\$1,000 value, \$25.00 minimum
E. Chapter 216, Buildings, Moving of Permit Fee:	
(1) For any building that is moved by use of heavy moving trucks or rollers	\$25.00
(2) For any building that is moved by the use of common carrier trucks or skids	\$5.00
