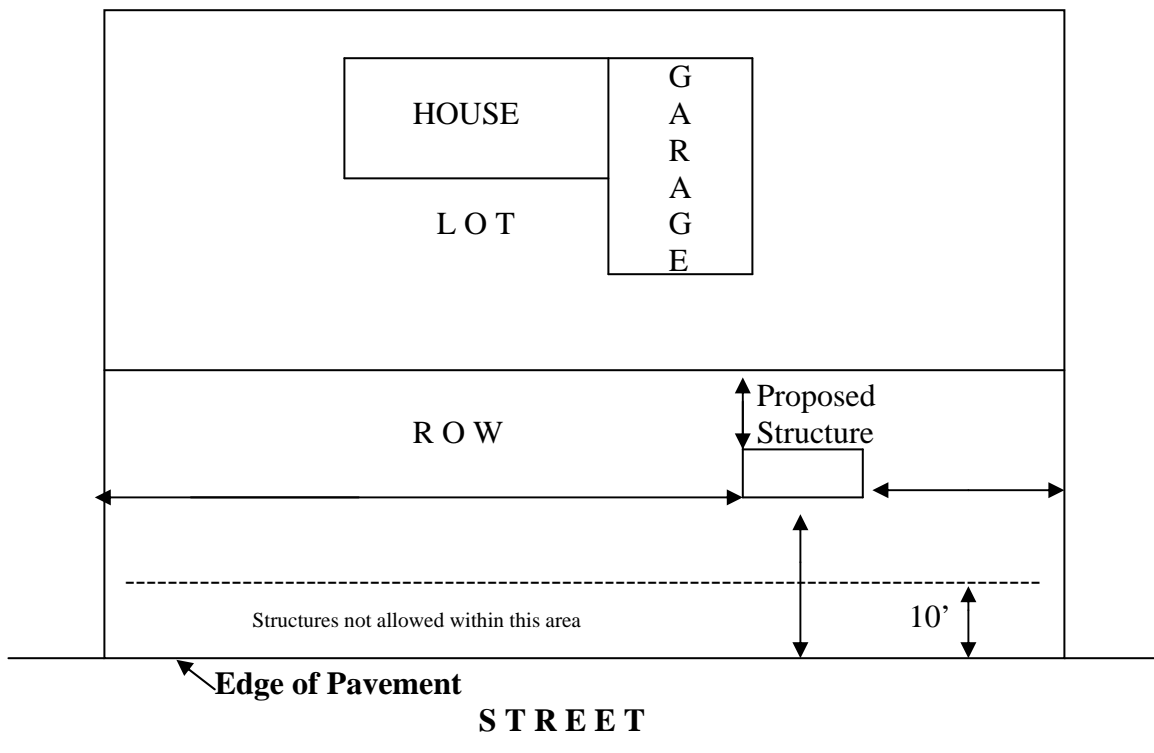

STRUCTURE APPLICATION REQUIREMENTS

Additional plot plan is required for a structure application. Plan is to show lot size, any buildings on the lot and their size, any other structures, fences on the lot/ROW, and the locations of the proposed structure. Also needed is a picture of the structure or a description.

(a) **STRUCTURES** are permitted in the Village's ROW and may be erected provided that the structure is maintained in good repair and comply with the following requirements:

(1) Structures are permitted, upon issuance of a permit, in the ROW of residential districts. No structures shall be allowed within 10' of edge of pavement.



(b) **VISION TRIANGLE** is a triangular-shaped portion of land established at street intersections in which nothing is erected, placed, planted or allowed to grow in such a manner as to limit or obstruct the sight distance of motorists entering or leaving the intersection. The size of the vision triangle shall be determined by the following Table and Figure:

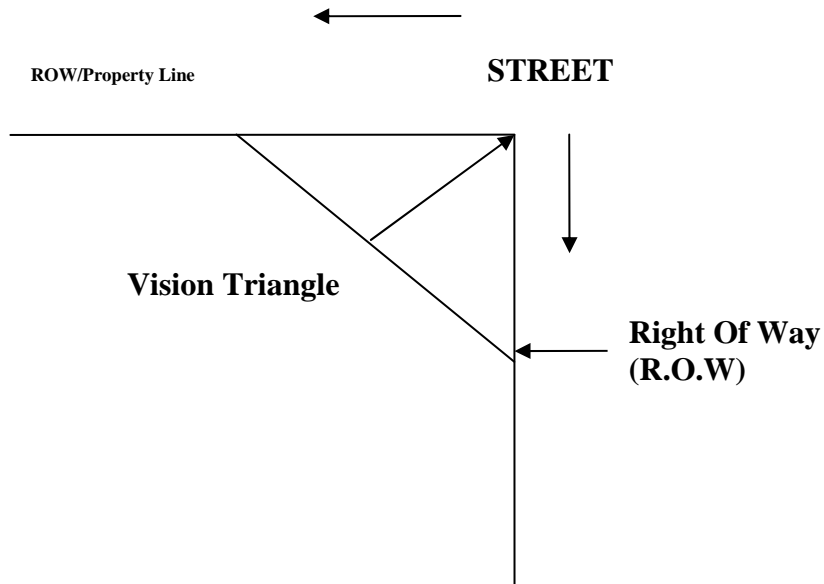
