As spring quickly approaches, the Village of Plover and its partners have identified a need to meet with the Springville Pond Management Committee (SPMC) and begin the process of updating the Springville Pond Management Plan (SPMP), last updated and approved in 2015. 1. Call to order. Mr. Worzalla called the meeting to order at 6:30pm.
2. Approval of the minutes of the meeting of December 9, 2014.

**Mr. Davies moved to approve the minutes of December 9, 2014 as written. Mr. Nafe seconded and the motion carried.**

3. Review and possible approval of Springville Pond Management Plan. Mr. Mahoney stated that Portage County Lakes and Rivers received an e-mail from Ryan Kluck, 2380 Heatherton Lane, in regards to dredging on the pond. Sarah Hull, Water resources Specialist, Center for Watershed Science & Education, responded to Mr. Kluck's inquiry noting that his e-mail was forwarded on to Dan Mahoney, Village of Plover Administrator, for insight as to what the Village plans to do as far as dredging is concerned. Mr. Mahoney read his e-mail response to Mr. Kluck (See attached copy of e-mail).

**\*\*RECOMMENDATION TO THE VILLAGE BOARD\*\* Mr. Davies moved that the Plan Commission recommend that the Village Board's February 18<sup>th</sup> meeting approve the Springville Pond Management Plan subject to any additional public input. Mr. Anderson seconded and the motion carried.**

Ms. Miskowski stated that the spring samples that are done on the pond by the Certified Monitoring Program at UWSP run \$81.00 per sample. Ms. Miskowski is still waiting to connect with Rich Boden, Wastewater System Manager at the Village on the types of analysis that they would be able to help out with although these results would not be able to be part of the state records. Committee to discuss if they feel a couple of spring samples should be done by UWSP so that results can be monitored.

4. Mr. Nafe moved, Ms. Miskowski seconded, to adjourn the meeting at 6:55pm. Motion carried.

## Springville Pond Management Committee - General Overview:



The Springville Pond Management Committee (SPMC) is a sub-committee of the Village of Plover Board. This committee meets to discuss matters related to the Springville Pond its health, improvement ideas, as well as recreational opportunities. Given action made by this committee may need Village Board approval, it is important for both Committee and Board members to be informed about a particular issue or proposal. The membership requirements and appointment process is identified below from *Chapter 21: Boards, Commissions and Committees* within the Villages Code of Ordinances. Although the formal board and committee makes the recommendations and takes action on different projects and policies as well as provides management recommendations, all the residents along the pond are strongly encouraged to attend meetings given action by this committee will have a direct effect on their properties along the Springville Pond.

**§ 21-9. Springville Pond Management Committee.** [Added by Ord. No. 16-86; amended by Ord. No. 6-99; Ord. No. 9-06]

- A. **Membership.** The Springville Pond Management Committee shall consist of seven members, including the Chairperson of the Public Works Committee, one Trustee of the Village Board and five property owners whose parcels abut Springville Pond appointed by the Village President for staggered five-year terms and confirmed by the Village Board.<sup>6</sup>
- B. **Powers and duties.** The Springville Pond Management Committee shall make recommendations to the Public Works Committee for cost-effective pond management in Springville Pond.<sup>7</sup>

# SPRINGVILLE POND MANAGEMENT PLAN UPDATE

## What is a Lake Management Plan?

A lake management plan is a dynamic document that identifies goals and action items for the purpose of creating, protecting and/or maintaining desired conditions in a lake and its watershed for a given period of time.

## Why do Lake Management Plans need to be updated?

A lake management plan is a living document that changes over time to meet the current needs, challenges and desires of the lake and its community. The goals, objectives and actions listed in this plan should be reviewed annually. It is recommended that this lake management plan be updated every five years with any necessary changes.

\*\*Springville Pond Management Plan was last updated in 2015.

## Springville Pond Lake Management Plan History

The Springville Pond management plan was developed by a committee of interested citizens, the Springville Pond Management Committee (a sub-committee of the Village of Plover Board of Trustees), and professionals who applied the data while actively gathering additional citizen input. A citizen survey was conducted in 2010 to learn about values, opinions, and any perceived issues with the pond. The survey was sent to all residents within the Springville Pond watershed. The survey was also available online for any members of the public interested in participating. Two hundred twenty-one (221) surveys were returned.

## Next Steps:

We intend to meet throughout 2022 in order to gather updated information about Springville Pond, it's health and the usage of the waterway in order accurately update the Management Plan.

## **EXISTING GOALS FROM THE 2015 SPRINGVILLE POND MANAGEMENT PLAN UPDATE**

**GOAL 1-UNDERSTAND THE SPRINGVILLE POND FISHERY SO THAT A SUSTAINABLE MANAGEMENT PLAN CAN BE CREATED AND FOLLOWED.**

**GOAL 2-CONTROL EXISTING AQUATIC INVASIVE PLANT SPECIES (AIS) AND PREVENT ANY NEW AQUATIC INVASIVE SPECIES FROM BECOMING ESTABLISHED IN SPRINGVILLE POND.**

**GOAL 3-ENHANCE SPRINGVILLE POND'S NATIVE AQUATIC PLANT COMMUNITY AND ECOSYSTEM.**

**GOAL 4-IMPROVE THE WATER QUALITY IN SPRINGVILLE POND. PHOSPHORUS CONCENTRATIONS WILL BE BELOW THE 2002/2004 ANNUAL AVERAGE OF 32.5 UG/L AND SUMMER AVERAGES WILL BE WELL BELOW THE WISCONSIN STATE STANDARD OF 40 UG/L.**

**GOAL 5-MAINTAIN HEALTHY FLOW ON THE LITTLE PLOVER RIVER AND WATER LEVELS IN SPRINGVILLE POND.**

**GOAL 6-WATERFRONT PROPERTY OWNERS AND LAKE USERS WILL BE INFORMED ABOUT THE IMPORTANCE OF SHORELANDS FOR A SUSTAINABLE AQUATIC ECOSYSTEM AND HOW THEIR ACTIONS CAN AFFECT THE HABITAT AND WATER QUALITY IN THE POND.**

**GOAL 7-CREATE, RESTORE AND PROTECT HEALTHY, STABLE SHORELINE HABITATS NEAR AND AROUND SPRINGVILLE POND. THIS GOAL WILL BE ACHIEVED WHEN ALL OF THE SHORELANDS AROUND SPRINGVILLE POND MEET OR EXCEED THE COUNTY AND STATE SHORELAND ZONING ORDINANCES.**

**GOAL 8-IMPROVE THE AESTHETIC BEAUTY AND RECREATION ON SPRINGVILLE POND.**

**GOAL 9-EVERY SHORELAND OR WATERSHED RESIDENT AND PARTNERS IDENTIFIED IN THIS PLAN CAN ACCESS INFORMATION REGARDING SPRINGVILLE POND AND THE ACTIONS OUTLINED IN THE MANAGEMENT PLAN.**

Please provide as much information as you can, there will be an opportunity at the end of the survey to provide additional comments, questions, concerns that may not be directly related to any of the questions within this survey.

This third and final section is intended to collect qualitative information related to your experiences and opinions associated with the Springville Pond. This section includes open ended questions and an opportunity to provide supplemental comments/concerns not related to any specific question or topic.
