§ A600-1. Village Fee Schedule. [Amended by Ord. No. 15-13; Amended by Ord. No. 5-16; Amended by Ord. No. 2-17; Amended by Ord. No. 3-18; Amended by Ord No. 1-19; Amended by Ord No. 8-20; Amended by Ord. No. 1-21]

A. Chapter 56, Finance and Taxation.

(1) Section 56-9, Room tax.

(a) Lodging permit: \$10 for initial permit; \$10 for renewal or reissuance after suspension or revocation of permit.¹

(b) Late filing fee for room tax return: \$10.

B. Chapter 185, Amusement Devices and Arcades.

(1) Coin-operated machine license: \$10 per year; license transfer: \$1.

(2) Amusement arcade license: \$100 per year.

C. Chapter 190, Animals.

(1) Dog license tax.

(a) Two dollars above the current Portage County licensing fee schedule for all dogs.

(b) One-half the license tax for dogs becoming five months after July 1 per year for all dogs required to be licensed under the Wisconsin Statutes.

(2) Dog license late fee: \$5.

(3) Replacement of lost dog license tag: \$1.

(4) Transfer of dog license: \$1.

(5) Multiple Dog License: \$10 above the current Portage County multiple dog license fee for up to 12 dogs, plus an additional \$2 per license above the current Portage County dog license fee for all dogs in excess of 12.

(6) Commercial animal establishment license: \$50 per year.

D. Chapter 212, Building Construction. [Amended by Ord. No. 5-16; Ord. No. 8-20]

(1) One- and two-family dwelling: \$.10 per square foot or fraction thereof, \$50 minimum.

(a) Plan review: \$50.

- (b) Early Start (footing and foundation only): \$50
- (c) State Seal: \$40
- (2) State permit, one- and two-family dwelling: \$5 plus state fee.
- (3) Multiple-family dwelling (three or more units): \$.12 per square foot or fraction thereof, \$75 minimum.
 - (a) Plan review: \$50 plus \$5 per unit.
- (4) Residential additions, private garages, accessory buildings, breezeways, decks, sheds, etc.: \$.10 per square foot or fraction thereof, \$50 minimum.
 - (a) Plan review: \$25 (may be waived by plan reviewer if minor review).
- (5) Commercial, manufacturing, industrial, and institutional buildings or additions thereto: \$.14 per square foot or fraction thereof, \$75 minimum.
 - (a) Plan review (new or addition): \$100 when State approved plan, \$200 when not State approved plan.
 - (b) Plan review (alteration): \$50.
 - (c) Early start (footing and foundation only): \$100.²
- (6) Electrical (where building area can be calculated).
 - (a) Residential: \$.06 per square foot or fraction thereof, \$25 minimum.
 - (b) Nonresidential: Administrative Fee of \$.05 per square foot or fraction thereof, \$25 minimum.
- (7) Plumbing (where building area can be calculated).
 - (a) Residential: \$.06 per square foot or fraction thereof, \$25 minimum.
 - (b) Nonresidential: Administrative Fee of \$.05 per square foot or fraction thereof, \$25 minimum.
- (8) HVAC (where building area can be calculated).
 - (a) Residential: \$.06 per square foot or fraction thereof, \$25 minimum.
 - (b) Nonresidential: \$.05 per square foot or fraction thereof, \$25 minimum.
- (9) All other buildings, structures and alterations except fences; repairs (in excess of \$1,000 value); electrical, plumbing and HVAC (where building area cannot be calculated); replacement windows, tennis courts, fireplace, wood stove, furnace, AC or duct changes, pools, hot tub, water heater unless identical equipment, softener, turf sprinkler, backflow device or plumbing fixture replacement, etc.: \$5 per \$1,000 of valuation or fraction thereof, \$25 minimum. (Note: permit is not required for roofing and siding or water heater replacement if you are replacing identical equipment.)

- (10) Fence: \$40.
 - (11) Sewer hookup: \$40 maximum.
 - (12) Fire protection district hookup.
 - (a) Initial hookup: \$150.
 - (b) Alterations: \$75.
 - (13) Special inspections made necessary by failure to comply with time limits set by notice or re-inspection for failure to comply with Chapter 212, Building Construction: \$50 each. [Amended by Ord. No. 15-13]
 - (14) Radiant heating unit: \$25.
 - (15) Occupancy (note: fee to be paid with building permit).
 - (a) Change of occupancy (nonresidential): \$50.
 - (b) Residential (new): \$20 plus \$10 per unit.
 - (c) Nonresidential (new): \$100.
 - (16) Failure to obtain permits prior to commencement of work (may also be subject to other legal remedies): double fees.
 - (17) Proceeding with work without notification for required inspection (may also be subject to other legal remedies): \$50.
 - (18) Building appeal: \$75.
 - (a) Variance from state code: contact Wisconsin Department of Commerce, Safety and Buildings Division.
 - (19) Moving permit: see Chapter 216 of this Code and Subsection E below.
 - (20) Razing.
 - (a) Principal building: \$50.
 - (b) Accessory building: \$25
 - (21) Street opening: \$20.
 - (22) Sign: \$1.00 per square foot, \$25 minimum.
- E. Chapter 216, Buildings, Moving of. Permit fee:
- (1) For any building that is moved by use of heavy moving trucks or rollers: \$25.
 - (2) For any building that is moved by the use of common carrier trucks or skids: \$5.
- F. Chapter 234, Cigarettes and Tobacco Products. Cigarette retailer's license: \$100 per year.
- G. Chapter 241, Coin, Precious Metal and Secondhand Gun Dealers. Dealer's license: \$10 per year.

- H. Chapter 253, Direct Sellers and Solicitors. Investigation fee: \$10.
- I. Chapter 260, Driveways and Culverts. Driveway permit or culvert permit: \$20. [Amended by Ord. No 5-09]
- J. Chapter 310, Housing Standards. Rooming house license: \$15 for up to four units and \$5 for each additional five units or fraction thereof.
- K. Chapter 328, Intoxicating Liquor and Fermented Malt Beverages.
 - (1) Class "A" fermented malt beverage retailer's license: \$50 per year.
 - (2) Class "B" fermented malt beverage retailer's license: \$75 per year.
 - (3) Temporary Class "B" license (picnic license): \$5 per event.
 - (4) Wholesaler's fermented malt beverage license: \$25 per year.
 - (5) Retail "Class A" liquor license: \$75 per year.
 - (6) Retail "Class B" liquor license: \$75 per year.
 - (7) Combination Class "B" fermented malt beverage and "Class B" intoxicating liquor license: \$150 per year.
 - (8) Retail "Class C" wine license: \$75 per year.
 - (9) Operator's license: \$20 for a period of one year; \$30 for a period of two years.
 - (10) Provisional license: \$15 for a period not to exceed 60 days.
 - (11) Reserve "Class B" liquor license: initial issuance fee of \$10,000 plus \$150 per year.
- L. Chapter 340, Junk Dealers and Salvage Yards.
 - (1) Junk dealer.
 - (a) License fee: \$25 per year or any fraction thereof.
 - (b) Investigation and inspection fee for the initial license: \$100.
 - (2) Automobile salvage yard.
 - (a) License fee: \$25 per year or any fraction thereof.
 - (b) Investigation and inspection fee for the initial license: \$100.
- M. Chapter 374, Mobile Homes and Mobile Home Parks.
 - (1) Mobile home park license: \$25 per year for 50 spaces or fraction thereof.
 - (2) Transfer fee: \$10.
- N. Chapter 388, Public Nuisances. Special Inspection made necessary by failure to comply with Chapter 388, Public Nuisances; \$50 each [Added by Ord. No. 15-13]
- O. Chapter 397, Parades, Carnivals and Exhibitions. Parade permit: \$25.

Chapter 401, Parks and Recreation. Worzella Pines Shelter rental fee: \$100 plus tax.

P. Chapter 402, Pawnbrokers. [Added by Ord. No. 15-10; Amended by Ord. No. 3-12]

(1) Pawnbroker license fee; \$210 per year.

Q. Chapter 431, Rummage and Garage Sales. License fee: \$10 per sale.

R. Chapter 455, Soda Water Beverages. License fee: \$5 per year.⁴

S. Chapter 460, Solid Waste. Garbage hauler's license fee: \$50 per year.

T. Chapter 467, Streets and Sidewalks.

(1) Street opening permit: \$20 per permit, except utility companies (phone, cable, electric and gas utilities) shall pay a permit fee of \$500 per year. [Amended by Ord. No. 5-09]

(2) Snow removal operator license fee: \$10 per vehicle/equipment per year or any fraction thereof.

U. Chapter 475, Taxicabs.

(1) Taxicab license: \$12.50 per vehicle per calendar year or part thereof.

(2) Taxicab driver license: \$35 per calendar year or part thereof.

(3) Provisional taxicab driver license: \$5.

V. Chapter 496, Vehicles and Traffic.

(1) Vehicle storage fee: \$10 per day.

(2) List of vehicles to be sold: \$1.

(3) Fee to offset junking charges: \$25.

(4) Bicycle registration fee: \$3.

W. Chapter 502, Wastewater Utility. [Amended by Ord. No. 10-10]

(1) Sewer user rates.

(a) The quarterly service charge shall be charged pursuant to the following schedule:

- (b) The rate for normal sewage shall be \$3.30 per 1,000 gallons.
- (c) The rates for surcharge are as follows:
 - [1] For all BOD in excess of 200 milligrams per liter: \$0.35 per pound.
 - [2] For all TSS in excess of 275 milligrams per liter: \$0.42 per pound.
 - [3] Phosphorus in excess of eight milligrams per liter: \$6.69 per pound.
 - [4] Ammonia in excess of 20 milligrams per liter: \$2.90 per pound.
- (2) Sampling costs. The standard cost for routine BOD testing shall be \$10 per sample. The standard cost for TSS testing shall be \$10 per sample. The standard cost for routine phosphorous testing shall be \$10 per sample. The standard cost for routine ammonia testing shall be \$10 per sample.
- (3) Atypical waste rates.
 - (a) A monthly service charge of \$30.
 - (b) Per 1,000 gallons: \$2.85.
 - (c) Per pound of BOD: \$0.31.
 - (d) Per pound of TSS: \$0.38.
 - (e) Per pound of phosphorus: \$6.12.
 - (f) Per pound of ammonia: \$2.64.
- (4) Septage fees.
 - (a) A monthly service charge of: \$30.
 - (b) Septic tank sludge: \$28.00 per 1,000 gallons, effective July 1, 2010; \$32.00 per 1000 gallons effective January 1, 2011.
 - (c) Holding tank sewage: \$10.00 per 1,000 gallons.
- (5) Application for septage disposal: filing fee of \$20.
- (6) Meters for private wells, quarterly service fee:

Z. Chapter 550, Zoning.

- (1) Satellite dish permit fee: \$10.
- (2) Conditional use: \$75.
- (3) Zoning amendment: \$145.
- (4) Variance: \$75.
- (5) Planned development district: \$145.
- (6) Zoning amendment with Comprehensive Plan amendment: \$215.
- (7) Special Plan Commission and Village Board meetings.
 - (a) Special Plan Commission meeting with necessity for publication of notice of public hearing: \$150.
 - (b) Special Plan Commission meeting with no necessity for publication of public hearing: \$135.
 - (c) Special Village Board meeting: \$135.
